

APPLICATION TO ERECT A CEMETERY MEMORIAL

To: Town of Dalton, MA, Highway & Cemetery Dept..

Application is hereby made for permission to erect a memorial and for you to construct a foundation, if necessary, on the area described on the reverse side of this application, and permit the monument dealer who signs this application to furnish the memorial in accordance with the Rules and Regulations of the Highway & Cemetery Dept. (referred to as the Dept.)

It is understood that all memorial work is subject to all the Rules and Regulations of the Dept. in any way affecting monuments, markers, headstones or any other structures or memorials. Their manufacture, location, care, erection, removal or in any other regard, subject to all other Rules and Regulations of the Dept. now in force or hereafter adopted.

Should any memorial, in the opinion of the Dalton Cemetery Trustees (referred to as the Trustees) become unsightly, dilapidated or dangerous to visitors, it is understood that the Dept. shall have the right to remove the same at the expense of the lot holder or his or her heirs, after giving due notice in writing to the last known address of the lot holder on file in the cemetery office.

The undersigned, who represents that he, she, or they, is or are the sole and exclusive holder or holders of sepulture in the lot described herein hereby authorizes and request the Trustees to permit the erection of the memorial as described on the reverse side of this application, and the construction of a foundation, if necessary, and does hereby agree to all the terms, conditions and other provisions as set forth on

In the event of this application being signed by an agent of the lot holder the agent agrees to inform the lot holder of the provisions of this agreement and the Rules and Regulations the Dept. governing memorial work.

(If the holder is deceased, heirship or right of interest must first be established by affidavit before this application will be accepted, except in behalf of spouse or children.)

MONUMENT DEALER AGREEMENT

I certify that I have been authorized by the person making this application to prepare a memorial for the above described location and that the reverse side of this agreement contains the specifications and detailed sketch of this memorial.

I certify that this memorial is made entirely of first-grade material and guaranteed by me to be free from all flaws, defects and tool marks and that the workmanship on said memorial will be of the highest standard.

I hereby agree to abide by the Rules and Regulations of the Dept., now in force or hereafter adopted, in the erection of the memorial, and further agree that, if in the opinion of the Trustees should the completed memorial not comply with said Rules and Regulations, it will, at the request of the Trustees, be removed by me within three days of such request without cost to the Town of Dalton or the lot holder.

The undersigned further agrees to hold the Town of Dalton free from any liability whatsoever for damage to the memorial that may result from the installation of said memorial, before, during or after the setting of said memorial.

I hereby agree to pay for any damage to lots, graves, walks, trees, shrubs, memorials, etc. during the transportation and setting of this memorial. I hereby agree to indemnify, defend and save harmless the Town of Dalton upon, or from, any and all claims, demands or alleged causes of action arising by reason the erection of said memorial.

I hereby agree to pay the foundation charges of the Dept.

No memorial, once erected, may be removed from the cemetery without written permission of the Trustees or of a court order.

No tools, equipment, structure, etc., required in the erection of the memorial may be left overnight in a cemetery without written permission of the Dept.

Acceptance of this permit by the Dept. and the payment for foundation charges or other payments do not constitute complete approval of this application.
